In accordance with Government Ordinance No. 26/2000 on Associations and Foundations as amended

as founding members according to the protocol concluded during the incorporation meeting of 04.07.2012, based on the freely expressed consent, have decided to establish a non-profit, apolitical, non-governmental, non-profit, non-ethnic, non-denominational, independent Association with legal personality consisting of natural persons, to promote the increase of professional competitiveness in the field of diabetic neuropathy.

CHAPTER I NAME, REGISTERED OFFICE OF THE ASSOCIATION, DURATION

Article 1. Name of the Association:

The Association will be called:

"SOCIETATEA DE NEUROPATIE DIABETICĂ" [SOCIETY OF DIABETIC NEUROPATHY] ASSOCIATION

according to the Evidence of Name Availability No. 112688/25.05.2012, issued by the Ministry of Justice, Communication and Public Relations Service, hereinafter referred to as the "SOCIETATEA DE NEUROPATIE DIABETICĂ" [SOCIETY OF DIABETIC NEUROPATHY]

Article 2. Association Registered Office:



The Association's registered office shall be in Romania, Cluj-Napoca, str. Ady Endre nr. 44, ap. 6/1, Cluj County

The association, as a Romanian legal entity, can set up representations, with territorial structures in the country and abroad, with due observance of the legal provisions.

The Association is required to state, in the documents it issues, the name, registered office, the registration number in the National Register, the fiscal code and the initial share capital.

Article 3. Purpose and Duration:

The purpose of the SOCIETATEA DE NEUROPATIE DIABETICĂ [SOCIETY OF DIABETIC NEUROPATHY] Association is to carry out medical, scientific activities, research and professional training in the medical field, clarification, expansion of the scientific material base for the development and study of diabetic neuropathy in Romania, to promote and support the integration of Romania in the European Union from a medical perspective as well and to provide medical care.

The duration of the Association is indefinite as from its registration in the Register of Associations and Foundations of the Cluj Court.

CHAPTER II MANAGEMENT AND CONTROL BODIES, ASSOCIATION'S SHARE CAPITAL

Article 4. The Association shall have the following governing bodies:

III. Censor:

CECALECEAN CRISTINA IOANA, registered on the List of the Body of Expert Accountants and Certified Accountants of Romania with book no. 28769/2007.

Article 5. If the number of members of the Association exceeds 100 people, the internal financial control shall be exercised by a commission of censors, composed of an odd number of members.

Article 6. The initial share capital of the Association is RON 1,250 (RON one thousand two hundred and fifty), established entirely from cash contribution of the founding members, recorded in a bank account in the name of the Association as follows:
